




- WHEREAS, the Municipality of Lapuyan, Zamboanga del Sur intends to purchase the **Pakyaw Labor for the Construction of Isolation/Quarantine Facilities during Covid-19 response** as reflected in the approved Purchase Request (PR) No. **2020-06-059-A** with an approved budget for the contract (ABC) of **Twenty Five Thousand Seven Hundred Seven Pesos Only (Php 25,707.00)** as contained in the Supplemental Procurement Plan CY 2020 of *Bayanihan* Grant to Municipalities and Cities;


