Resolution Declaring the Lowest Calculated and Responsive Quotation (LCRQ) and
Recommending the Award to **Kanakan S. Mangumpig** for the **Pakyaw Labor for the
Construction of Staircase @ Waterfalls Park**

WHEREAS, the Municipality of Lapuyan, Zamboanga del Sur declared First and Second Failure of Biddings for the **Pakyaw Labor for the Construction of Staircase @ Waterfalls Park** under BAC Resolution No. **WP-2020-077**;

WHEREAS, due to two-failed biddings, the Bids and Awards Committee resorted to Negotiated Procurement under Two-Failed Biddings;

WHEREAS, the BAC invited suppliers and posted Request for Quotation with an Approved Budget for the Contract of **One Hundred Eighteen Thousand Four Hundred Two Pesos Only (Php 98,160.00)** for the **Pakyaw Labor for the Construction of Staircase @ Waterfalls Park** under RFQ reference number **PB-LAP-2020-124** in the PhilGEPS portal and in conspicuous place of the LGU on **October 17, 2020**;

WHEREAS, in response to the said posting, three (3) prospective suppliers submitted their proposals and were found to be substantially complying and responsive;


