Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Improvement of Executive Building @ Municipal Compound. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
