The Local Government Unit of Lapuyan, through the LBP Loan Proceeds intends to apply the sum of Thirty Two Million Two Hundred Sixty Seven Thousand Seven Hundred Thirty Five Pesos & 82/100 (Php 32,267,735.82) being the Approved Budget for the Contract (ABC) to payments under the contract for Rehabilitation and Upgrading of Existing Municipal Public Market. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Rehabilitation and Upgrading of Existing Municipal Public Market. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary

"pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on January 20, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference 1 February 01, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS.. which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.
