The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference1 January 25, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS.. which shall be open

to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
