Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Concreting of Lubosan Multi-Purpose Pavement. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference NA. which shall be open to prospective bidders.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
