The Local Government Unit of Lapuyan, through the 20% EDF 2023 intends to apply the sum of Two Million Five Hundred Pesos Only (Php 2,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting of Municipal Streets (Apostol Sr. Street). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Concreting of Municipal Streets (Apostol Sr. Street). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Local Government Unit of Lapuyan and inspect the Bidding Documents at the address given below from 8:00AM – 5:00PM.

5. A complete set of Bidding Documents may be acquired by interested bidders on May 26, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference 1 June 7, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS.. which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

10. Bid opening shall be on June 21, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
