Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Construction of Concrete Pavement @ Market Area. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference¹ NA. which shall be open to prospective bidders.
