## Description

Republic of the Philippines Province of Zamboanga del Sur Municipality of Lapuyan Invitation to Bid for CONSTRUCTION OF CONCRETE PAVEMENT @ MARKET AREA

The Local Government Unit of Lapuyan, through the 20% EDF intends to apply the sum of Five Hundred Thousand Pesos Only (Php 500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Concrete Pavement @ Market Area. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Lapuyan now invites bids for the above Procurement

Project. Completion of the Works is required Construction of Concrete Pavement @ Market Area. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
