The Local Government Unit of Lapuyan, through the 20% EDF 2024 intends to apply the sum of One Million Five Hundred Pesos Only (Php 1,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF CONCRETE CANAL WITH SHOULDERS AT SINDAWAY STREET SEGMENT. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required CONSTRUCTION OF CONCRETE CANAL WITH SHOULDERS AT SINDAWAY STREET SEGMENT. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on January 25-February 21, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference¹ February 07, 2024 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS.. which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.

The Local Government Unit of Lapuyan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
