The Local Government Unit of Lapuyan, through the 20% EDF 2024 intends to apply the sum of One Million Pesos Only (Php 1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for FLOORING OF LUANAN MULTI-PURPOSE PAVEMENT (COVERED COURT). Bids received in excess of the ABC shall be automatically rejected at bid opening.  
 2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required FLOORING OF LUANAN MULTIPURPOSE PAVEMENT (COVERED COURT). - 6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference 1 February 07, 2024 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS., which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.
