THIS AGREEMENT, made and entered into this 4<sup>TH</sup> day of November 2022 by between the **Local Government Unit of Lapuyan, Zamboanga Del Sur** represented herewith by the **Municipal Mayor** and duly authorized for the purpose and hereinafter referred to as the **IMPLEMENTING AGENCY** and the Pakyaw Labor herein after referred to as the **PAKYAW GROUP** and herein represented by their Pakyaw Group Leader **KANAKAN S. That for and in consideration of the rates in the SCHEDULE OF WORK, attached as Annex B to this Agreement and made an integral part hereof, PARTIES hereto covenant and agreed as follows:

1. That one Pakyaw Group shall provide labor only necessary for the proper and faithful performance of the work describe below at the total contract amount of Fifty Two Thousand Eight Hundred Pesos Only (PHP 52,800.00).
2. That the Pakyaw Group shall complete the work in accordance with corresponding Plans and Specification, under the supervision of the site supervisor appointed for the process by the Municipal Engineer.
3. That the Pakyaw Group shall comply with all the terms and conditions of this contract more specifically those contained in the following documents attached herein.

4. That the Pakyaw group agrees to commence work within seven (7) days upon signing of this contract and to complete the same within what is stipulated in the POW, excluding Sundays and legal Holidays.
