- 2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required Maintenance of Lapuyan Slaughter House. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference NA which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on October 18, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
