Invitation to Bid for REPAIR/IMPROVEMENT OF MUNICIPAL STREET SEGMENT-RE: APOSTOL SR. STREET

The Local Government Unit of Lapuyan, through the 20% EDF 2023 intends to apply the sum of Two Million Five Hundred Pesos Only (Php 2,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for REPAIR/IMPROVEMENT OF MUNICIPAL STREET SEGMENT-RE: APOSTOL SR. STREET. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Lapuyan now invites bids for the above Procurement Project. Completion of the Works is required REPAIR/IMPROVEMENT OF MUNICIPAL STREET SEGMENT-RE: APOSTOL SR. STREET. Bidders should have completed a contract similar to the Project. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The Local Government Unit of Lapuyan will hold a Pre-Bid Conference October 25, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS.. which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before [insert time and date]. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on November 08, 2023 @ 2:00 p.m at 2F New Municipal Hall, Lapuyan ZDS. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
