

WHEREAS, the Municipal Treasury Office of the LGU, of this municipality (End User) submitted a purchase request for the **Rental/Subscription of Software (Real Property Tax System)** for the use in the Office of Municipal Treasury amounting to **Php. 100,000.00**;

WHEREAS, Servicing Agency owns or has access to the necessary tools and equipment required for the procurement and is technically, legally and financially capable to deliver the services at most advantageous price and contract for the Government;
