



KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made and entered into this 7th day of October 2025 by between the **Local Government Unit of Lapuyan, Zamboanga Del Sur** represented herewith by the **Municipal Mayor** and duly authorized for the purpose and hereinafter referred to as the IMPLEMENTING AGENCY and the Pakyaw Labor herein after referred to as the PAKYAW GROUP and herein represented by their Pakyaw Group Leader **Danny V. Ortega**.

WITNESSETH

That for and in consideration of the rates in the SCHEDULE OF WORK, attached as Annex B to this Agreement and made and integral part hereof, PARTIES hereto covenant and agreed as follows:
